1. The college shall appoint qualified teaching faculty including Principal as per NCTE Norms through the duly constituted Selection Committee as per Kurukshetra University Rules and get the proceedings of the Selection Committee approved from the University. The teaching/non-teaching staff shall be appointed on regular basis and on the pay scales prescribed by the State Govt./Kurukshetra University.
2. The college shall abide by the norms and standards/rules and regulations as prescribed by the NCTE/Kurukshetra University from time to time.
3. The faculty shall join before the commencement of the course.

Kindly note that it is only provisional affiliation. In case the college is found deficient in infrastructural facilities/teaching faculty and/or acting in violation of University directions, Rules, Regulations, Ordinance etc., the college shall be liable for penalties/disciplinary action including withdrawal of provisional affiliation.
